**Angela Kelly**

*Coordinating Team Member, Boston Immigration Justice Accompaniment (BIJAN and/or "Beyond")*

Angela Kelly is a member of the coordinating team of the Boston Immigration Justice Accompaniment Network (BIJAN, a.k.a. "Beyond"), a grassroots network of individuals, faith communities, and activist groups working together with those most targeted by ICE locally to reduce the escalating harm and racism of immigration detention and deportations. BIJAN provides accompaniment in many forms, including at court and ICE check-ins, through a bond and legal defense fund, and by offering community support to those released from ICE jail. Through these efforts, BIJAN also builds relationships to organize in solidarity with the wider movement to #FreeThemALL. In addition to her involvement with BIJAN, Angela serves as Senior Associate for Justice Education at the UU College of Social Justice, is trained as a mental health clinician, and has worked with a variety of peace, justice, youth-focused and community-building initiatives.



**Cindy C. Liou, Esq.**

*State Policy Director, Kids In Need of Defense (KIND)*

Cindy C. Liou, Esq. is the State Policy Director at Kids in Need of Defense (KIND), a national non-profit working to provide legal counsel to unaccompanied refugee and immigrant children in the United States. Prior to this role, she served as the Deputy Director of Legal Services at KIND. Previously, she was the Director of the Human Trafficking Project at Asian Pacific Islander Legal Outreach, where she also co-counseled several civil litigation cases on behalf of human trafficking survivors, and represented survivors of domestic violence, sexual assault,



elder abuse, and hate crimes. She continues to provide consulting and training on topics ranging from human trafficking, domestic violence lethality, to best practices on how to collaborate in cross-disciplinary teams to support survivors of violence. She is formerly the Co-Chair of the Policy Committee of the Freedom Network to Empower Trafficked and Enslaved Persons (USA), a network of over 40 individual and member agencies representing trafficking survivors, and the winner of their 2018 Paul and Sheila Wellstone Award. She is also the recipient of the 2013 San Francisco Collaborative Against Human Trafficking Modern Day Abolitionist Award for Policy and Advocacy. Cindy is the co-author of several articles, the second edition of the manual *Representing Survivors of Human Trafficking*, and the first edition of *T Visas: A Critical Immigration Option for Survivors of Human Trafficking*. She previously handled a variety of pro bono cases at Wilson Sonsini Goodrich & Rosati PC, ranging from asylum to police misconduct cases. Cindy is a graduate from Stanford Law School and the University of Washington.

### **Wendy Miron, LCSW**

*Senior Director of Social Services, Kids In Need of Defense (KIND)*

Wendy Miron, Senior Director for Social Services, leads an exemplary national team in the design and implementation of Trauma-Informed frameworks that advance best practices to working with unaccompanied minors who are receiving legal representation. Committed to bearing witness to the resilience and cultural wealth of communities, Wendy is a Licensed Clinical Social Worker with over fifteen years of clinical and management experience in the non-profit sector working with immigrant youth and families in organizations across New York City including Sanctuary for Families, Union Settlement, Mental Health Providers of Western Queens and as a consultant at Safe Passage. Prior to joining KIND, Wendy served as Program Director for the Parenting and Child Development Program at LSA Family Health Service in East Harlem, NY. She has been an active member of local and national coalitions that promote child wellbeing and equity in immigrant communities, including work with the New York Immigration Coalition (NYIC) and Vital Villages' Networks of Opportunities for Child Wellbeing (NOW), as well as being part of Anchoring Achievement in Mexican Communities. Wendy has presented at various symposiums and conferences throughout the years on best practices in working with migrant families, and therapeutic interventions for children impacted by trauma. Wendy was born and raised in Guatemala and migrated to South Florida at the age of ten. She holds a master's degree in Social Work from Columbia University, an undergraduate degree in Anthropology and Religious Studies from Florida International University, and a graduate program in Parent Infant Mental Health and Trauma from Adelphi University.

*Manager of Education Policy, New York Immigration Coalition (NYIC)*

Liza Schwartzwald is the NYIC Manager of Education Policy. She focuses on Early Childhood Education and Care, Adult Literacy, and the Two-Generation Approach, and works to uplift educational opportunities for immigrant families and English Language Learners in New York in a holistic and integrated way. She previously worked as a Policy and Advocacy Associate at United Neighborhood Houses, where she worked on the Families United for Learning and Literacy (FULL) family literacy initiative.

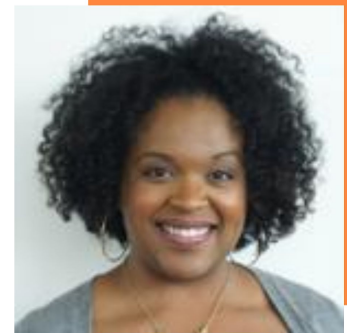
